MEMORANDUM OF ASSOCIATION OF SUN PHARMA ADVANCED RESEARCH COMPANY LIMITED

- I. The Name of the Company is SUN PHARMA ADVANCED RESEARCH COMPANY LIMITED.
- II. The Registered Office of the Company will be situated in the State of Gujarat.
- III. The objects for which the Company is established are
- (A) THE MAIN OBJECT OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS REGISTRATION IS:
 - 1. To undertake and carry on all types of scientific and technical research, experiments, process development, product development, toxicity studies, clinical trials, efficacy trials, bio equivalency studies, analytical methods study, developing New Chemical Entities (NCE's) and Novel Drug Delivery Systems (NDDS), and test/study /trial of all kinds including such work for others, to conduct and carry on research on NCE's to find a lead molecule, optimization, biological assay systems, animal disease models, toxicology studies, to conduct and carry on research on NDDS to have new product with potential advantages, to conduct study and/or develop methods ,technologies ,systems for delivery devices, instruments, softwares and any other matters/mediums and to sell, licence, lease and otherwise transfer studies and research both scientific and technical investigations, process and product development and invention including innovative in pharmaceutical formulations, bulk drugs, drug delivery systems to pharmaceutical and other companies and other persons and to establish, provide, maintain, licence and conduct or otherwise subsidize research and development laboratories or facilities and experimental workshops for scientific and technical research.

(B) OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECT:-

2. To apply for, purchase or otherwise acquire and protect, prolong and renew patent rights, secret processes, inventions, designs, trade marks, trade names, licenses, protections and concessions which may appear likely to be

advantageous or useful to the Company and to spend money in experimenting and testing and improving or seeking to improve any patents, inventions or rights which the Company may acquire or propose to acquire or develop.

- 5. To send out to foreign countries directors, employees or other persons for investigation of possibilities for promoting the R & D activities carried on by the Company or for procuring and buying any equipment or for establishing any arrangements in promoting the interest of the Company and to pay for all expenses in this connection.
- 6. To vote upon or in respect of any shares, securities, bonds, notes, other evidence, interest or application of any corporations, trusts, association or concern whether or not affecting the security or the apparent security of the trust property or the purchase or sale or lease of the assets of any suchcorporation, trust, association or concern and to enter into or establishing any voting trust in respect of any such shares, securities or property and to appoint, remove and replace any voting trustees either jointly with other/s or not, as they in their absolute discretion shall deem fit and to deposit any such shares, securities or property in any voting trustees or with any depository discriminatedthereby, and to give proxies or powers of attorney with or without power for substituting or for voting or acting on behalf of the trustees as the owner of any such property.
- 7. To undertake and execute any trust or discretion, the undertaking whereof may seem desirable, and the distribution amongst the beneficiaries, pensioners or other persons, entitled thereto of any income, capital annuity or other sum or sums of money or other property, whether periodically or otherwise, and whether in money or specie in furtherance of any trust, direction, discretion or other obligation or permission.

- 16. To sell, grant, licenses, easements and other rights over and in any other manner deal with or dispose *off*, the undertaking, property, assets, rights, and effects *of* the Company, or any part thereof for such consideration as the Company may think *fit* and in particular for shares, debentures or securities of any other Company.
- 17. To acquire and undertake the whole or any part of the business, property and liabilities *of* any person or Company carrying on or proposing to carry onbusiness which the Company is authorised to carry on, or possessed of property suitable for the purpose of this Company.
- 18. To establish or promote or concur in establishing or promoting any company or Companies having similar objects for the purpose of acquiring any company or Companies for the purpose of acquiring all or any of the property, rights and liabilities of the Company and to place or guarantee the placing *of*, underwrite, subscribe for or otherwise, acquire all or any part of the shares, debentures or other securities of any such other company.
- 19. To enter into any arrangement with any Government, or authority supreme, municipal, local or otherwise, or any person or company that may seem conducive to the Company's. objects or any of them and to obtain from any such Government authority, person or company any rights, privileges, charters, contracts, licences and concessions which the Company may think fit desirable to obtain, and to carry out, exercise and comply therewith.
- 20. To apply for promote and obtain any Act, charter; privileges, concession, licence, authorisation if any, Government, State or Municipality, provisional order or licence of any authority for enabling the Company to carry any of its objects into effect, or, for extending any of the powers of the Company, or for

effecting any modification of the Company's constitution, or for any other purpose which may seem expedient and to oppose any proceedings or applications which may seem calculated, directly or indirectly or prejudice the Company's interest.

- 21. To establish, provide, maintain and conduct or otherwise subsidise research laboratories and experimental workshops for scientific and technical research and experiments and to undertake and carry on with all scientific technical researches experiments and tests *of* all kinds and to promote studies and research both scientific and technical Investigations and invention by providing, subsidising, endowing or assisting laboratories workshops, libraries, lecture, meetings, and conferences.
- 22. To make donation to such persons or institutions and in such cases and either of cash or any other assets as may be thought directly or indirectly conducive to any of the Company's objects or otherwise expedient and in particular to remunerate any person or corporation introducing business to this Company and also to subscribe, contribute, or otherwise assists or guarantee money for charitable; scientific, religious or benevolent, national, public *or* other, Institutions objects or for any exhibition or for any public, general or other objects and to establish and support *or* aid in the establishment and support *or* associations, institutions, funds, trusts and convenience for the benefit *of* the employees or ex employees (including Directors) of the Company or its predecessors in business or of persons having dealings with the Company or the dependents, relatives or connection of such persons and in particular friendly or other benefit societies and to grant pensions, allowances, gratuities and bonuses either by way of annual payment or a lumpsum and to make payments towards insurance and to form and contribute to provident and benefit funds of or for such persons.
- 23. To refer or agree to refer any claims, demand, dispute or any other question, by or against the Company, or in which the Company is interested or concerned, and whether between the Company and the member or members or his or their representatives, or between the Company and third parties, to arbitration in India or at any place outside, India, and to observe and perform and do all acts, deeds, mailers, and things to carry out or enforce the awards.
